What is the Train-the-Trainer Programme?

The **Train-the-Trainer Programme on Preventing and Investigating Corruption** comprises sixteen masterclass sessions designed by GIACC, WFEO-CAC and Globethics MENA Centre for the personnel of governments, law enforcement bodies, public and private sector organisations, and professional institutions.

The programme is designed for online delivery with four (4) training suites spread over sixteen (16) separate online sessions taking place between October 2024 and June 2025.

Each masterclass session will run between one and a half to two hours, and will be led by the suite instructor(s) with contributions from other speakers from the collaborating institutions, followed by discussion (or breakout sessions) and questions from participants.

Get certified as an Anti-Corruption Trainer

Participants who complete all the sessions and display sufficient understanding and ability during the sessions will **qualify as trainers and be issued a certificate of completion**. Furthermore, they will receive authorisation from the collaborating partners to use the training slides and to **act as trainers in their home country**.

The condition of this authorisation will be that the workshops are held under the auspices of the relevant national professional institution. It will be permissible for the national professional institution and the trainer to charge reasonable fees in the workshops in their home country. Regulatory bodies or professional institutions may choose to allocate continuing professional development points to participants who take these workshops.

GIACC, WFEO-CAC and Globethics (MENA) do not charge a fee to professional institutions for using the slides under this programme.

What to expect

- Prior to each session, participants will be sent detailed PowerPoint presentations and required to read through them ahead.
- Participants will be encouraged to: (1) discuss the content of each presentation; (2) contribute ideas as to how the content may be expanded and improved; and (3) consider how the presentation may be modified if necessary for local content and conditions.
- Upon completing the sixteen sessions, participants will be confident to offer the workshops in their home country.

Instructors



Neill Stansbury is the Co-founder and Director of GIACC. He is a construction lawyer who has worked for over 40 years in the international infrastructure sector. He was Chairman of the International Organization for Standardization Anti-Bribery Project Committee which published ISO 37001, Chairman of British Standards Institution Anti-Bribery Working Group which published BS 10500, and Vice Chairman of the World Federation of Engineering Organisation's Anti-Corruption Standing Committee. He was an independent anti-corruption compliance monitor of Balfour Beatty, Parsons Brinckerhoff and Mabey Bridge. He has given anti-corruption presentations and workshops in over 40 countries.

Kamel Ayadi is the Founding Chairman of the WFEO, Anti-corruption Committee, Past president of the WFEO, Chairman of GIACC Tunisia and Regional Consul of Globethics MENA. He leads several global anti-corruption initiatives. He participates as an expert in the drafting committee for the ISO standard on COI. He has also participated in the drafting of the ISO 37001 anti-bribery standard. He has held high-level positions, including Minister of Governance and Anti-corruption in Tunisia and Chairman of the High-Level Authority for Administrative and Financial Control.



Christoph Stückelberger, Prof. Dr Dr h.c., is a professor of Global Ethics and the Founder and Honorary President of Globethics, with regional offices across the world. He is also the Founding President of Transparency Switzerland 1996ff and, an anti-corruption trainer in business, public, nogo, educational and religious sectors. He is a prolific author and an editor of several books and articles on corruption, e.g. "Corruption-free religions are possible" (Globethics 2021).

Michael Kramer is a US-based attorney and consultant who specialises in providing investigative and consulting services to international clients in the area of corruption. His clients have included the World Bank, numerous US Government and United Nations Agencies, USAID, the Millennium Challenge Corporation, the European Investment Bank, the Asian Development Bank, numerous bilateral aid agencies and International Humanitarian NGOs, as well as eight of the ten largest multi-national corporations. Before entering the private sector, Mr. Kramer was a Special Attorney with the United States Department of Justice, Organized Crime and Racketeering Section, assigned to the investigation and trial of corruption cases throughout the US.



Paul M. Heywood, PhD, FRSA, FAcSS, holds the Sir Francis Hill Chair of European Politics at the University of Nottingham, UK. His research work focuses on political corruption, institutional design, and state capacity. He is author, co-author or editor of several books, journal articles and book chapters. Heywood currently leads the Global Integrity Anti-Corruption Evidence (GI-ACE) programme, designed to identify new initiatives that can help developing countries tackle the scourge of corruption. He is also co-founder of CurbingCorruption.com, a Trustee of Transparency International (TI)-UK and a Member of the TI International Council.

Joshua George is a Quality Assurance Expert in Higher Education. He has worked in Malaysia, Saudi Arabia, New Zealand and India in the Higher Education Sector. He is currently the Associate Director of International Rankings and Accreditations at Woxsen University.

Learning Suite Content Summary

Suite I: Corruption in Infrastructure Projects (prevention & Investigation)

Instructor: Neill Stansbury

Institution: GIACC - International

- Unit 1 *Why infrastructure projects are prone to corruption:* An explanation of the factors which allow corruption to flourish on infrastructure projects, such as complex contractual structure; diversity of skills; number of project phases; cost of large projects; uniqueness of projects; technical complexity of projects; location of projects; ability to conceal corruption; and insufficient anti-corruption controls.
- Unit 2 *Contractual structure, rights and obligations on infrastructure projects:* An explanation of: (1) how infrastructure projects are contractually structured; (2) the different project participants; and (3) the various contractual documents, such as general conditions of contract, special conditions of contract, drawings, technical specification and bill of quantities. This explanation helps us understand how corruption can be concealed within the structure of these documents.
- Unit 3 *How corruption takes place in the procurement phase of an infrastructure project:* An explanation of the types of corruption which occur during the procurement phase of an infrastructure project, such as bribery, fraud, and cartels, with examples of how it takes place.
- Unit 4 *How corruption takes place in the construction phase of an infrastructure project:* An explanation of the types of corruption which occur during the construction phase of an infrastructure project, such as bribery, fraud and extortion, with examples of how it takes place.
- Unit 5 *How to prevent corruption in the procurement phase of an infrastructure project:* An explanation of necessary measures which should be implemented, which can help prevent corruption during the procurement phase of an infrastructure project, such as corporate compliance procedures; controls on personnel; due diligence on bidders; tender and contract conditions; competition; objectivity; control of exemptions; fair bid evaluation; transparency; auditing; monitoring; and reporting
- Unit 6 *How to prevent corruption in the construction phase of an infrastructure project:* An explanation of necessary measures which should be implemented, which can help prevent corruption during the construction phase of an infrastructure project, such as corporate compliance procedures; controls on personnel; project code of conduct; raising awareness; controls over quality, quantity, rate adjustment, variations, programme, certification and payment; transparency; auditing; monitoring; and reporting.

Unit 7 *How to investigate corruption in the procurement phase of an infrastructure project:* An explanation of good investigative practice in relation to suspected corruption in the procurement phase, including factors which complicate investigation; appointing technical and commercial experts; reviewing documentation (tender documents, bid submissions, bid evaluation, contract conditions, drawings, specification, and programme); personnel interviews; internet searches; bank record checks; comparison of bid data; identifying inconsistencies in evidence; and identifying who is responsible.

Unit 8 *How to investigate corruption in the construction phase of an infrastructure project:* An explanation of good investigative practice in relation to suspected corruption during the construction phase, including factors which complicate the investigation; proving the corruption; appointing technical and commercial experts; inspecting the site; undertaking tests; reviewing the documentation (contract, quality, quantity, programme, correspondence, claims for payment, photographic records); personnel interviews; identifying inconsistencies in evidence; and identifying who is responsible.

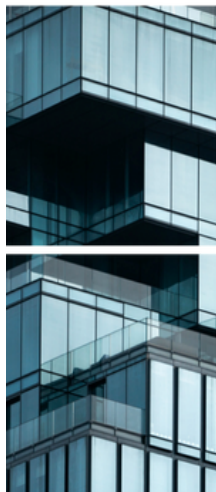
