Environmental Impact Assessment and Management''

Introduction:

Environmental Impact Assessment (EIA) is a key tool for analyzing the impacts of the new project proposals on the environment, for integrating environmental concerns in to the project, mitigating any adverse impacts and providing a forum for public participation in the decision-making process. In general, EIAs are being carried out by national/international consultancies, and submitted to national governmental authority for review and approval. The implementation of the EIA in the Gulf region becomes increasingly important nowadays with rapid expansion in infrastructure and industrial as well as other projects within the region.

Objectives:

The overall aim of this training workshop is to enable the participants to build their capacity to integrate environmental concerns in project proposals. This workshop will provide better understanding of the EIA purposes and benefits. At the completion of this course, the participant will learn the principles, procedures and practices of integrating environment through EIA and will enable to practically conduct an EIA study for a project proposal.

Course Methodology:

Quizzes, role play, case studies, class room discussions and team work will be part of our training course to enhance the learning process. It will be encouraged that each participant will have opportunity to share his/her ideas or make enquiries how this training course can improve their role in their institution.
